A PUBLIC HEARING WILL BE HELD before the Arizona Power Plant and Transmission Line Siting Committee (“Committee”) regarding the Application of EAGL, LLC (“Applicant”) for a Certificate of Environmental Compatibility (“CEC”) authorizing construction of the Eagle Eye Thermal Plant and Gen-Tie Project (“Project”). The Project includes an up to 700 megawatts (“MW”) natural gas-fired power generating facility and an approximately 4.3-mile 230 kilovolt (“kV”) transmission generation tie-line that will deliver electricity to the regional grid at the existing Harcuvar Substation in La Paz County. A map of the Project is attached as **Exhibit A**.

The hearing will be held at the Bluewater Resort and Casino, 11300 Resort Drive, Parker, AZ, 85344. **The hearing will begin on August 3, 2026, at 10:00 a.m. and will continue as necessary through Thursday, August 6, 2026, beginning at 9:00 a.m. each day at the same location until completion of the hearing.** If any additions or revisions to the hearing schedule are required, they will be noticed on the Project website at: <https://brightnightpower.com/eagle-eye-community/> and on the Arizona Corporation Commission (“ACC”) website at <https://www.azcc.gov/arizona-power-plant/hearings-and-meetings>.

4 DURING THE HEARING AT THE DISCRETION OF THE CHAIRMAN OF THE
5 COMMITTEE.

6 THE PUBLIC CAN WATCH THE HEARING ONLINE, LISTEN TO THE
7 HEARING VIA TELEPHONE, OR ATTEND IN PERSON. At least 24 hours in
8 advance of the hearing, information regarding online and telephone hearing access, as

12 The Chairman may, at his discretion, recess the hearing to a time and place to be
13 announced during the hearing, or to be determined after the recess. The date, time, and
14 place at which the hearing will be resumed will be posted on the above-noted Project
15 website and the ACC website. **NOTE: NOTICE OF ANY SUCH RESUMED**
16 **HEARING WILL BE GIVEN; HOWEVER, PUBLISHED NOTICE OF SUCH A**
17 **RESUMED HEARING IS NOT REQUIRED.**

18 If the Committee decides to conduct a tour, notice that includes a map and itinerary
19 of any such tour will be available at the hearing and posted on the Project website at:
20 <https://brightnightpower.com/eagle-eye-community/>. Members of the public may follow
21 the Committee on the tour. During the tour, the Committee may hear testimony at stops
22 on the tour concerning elements of the Project. No other discussion or deliberation
23 concerning the Application will occur during the tour. A court reporter or recording
24 device will record any testimony taken on the tour for transcription. Public health and
25 safety protocols specific for the tour will be included on the itinerary. If the Committee
26 decides not to take a tour, the hearing will continue as scheduled.

8 The Applicant will make available final copies of the pre-filing conference, pre-
9 hearing conference, and hearing transcripts at each of the above locations and website.

10 Each county, municipal government, and state agency interested in the Project that
11 desires to be a party to the proceedings shall, not less than ten (10) days before the date
12 set for the hearing, file a Notice of Intent to Become a Party with the Director of Utilities,
13 ACC, 1200 West Washington Street, Phoenix, Arizona 85007.

14 Any domestic non-profit corporation or association formed in whole or in part to
15 promote conservation or natural beauty, to protect the environment, personal health, or
16 other biological values, to preserve historical sites, to promote consumer interests, to
17 represent commercial and industrial groups, or to promote the orderly development of the
18 area in which the Project is located desiring to become a party to the proceedings shall,
19 not less than ten (10) days before the date set for the hearing, file a Notice of Intent to
20 Become a Party with the Director of Utilities, ACC, 1200 West Washington Street,
21 Phoenix, Arizona 85007.

22 The Committee may make other persons parties to the proceedings at any time.
23 Any person may make a limited appearance at a hearing by filing a statement in writing
24 with the Director of Utilities, ACC, 1200 West Washington Street, Phoenix, Arizona
25 85007, and the Chairman of the Committee at 2005 North Central Avenue, Phoenix,
26 Arizona 85007, not less than five (5) days before the date set for the hearing. A person
27

1 making a limited appearance will not be a party or have the right to present testimony or
2 cross-examine witnesses.

3 This proceeding is governed by Arizona Revised Statutes (“A.R.S.”) §§ 40-360 to
4 40-360.13 and Arizona Administrative Code R14-7-101 to R14-7-120. No substantive
5 communication, not in the public record, may be made to any member of the Committee.
6 The written decision of the Committee will be submitted to the ACC pursuant to A.R.S.
7 § 40-360.07. Any person intending to be a party to the proceedings on the matter before
8 the ACC must be a party to the proceedings before the Committee.

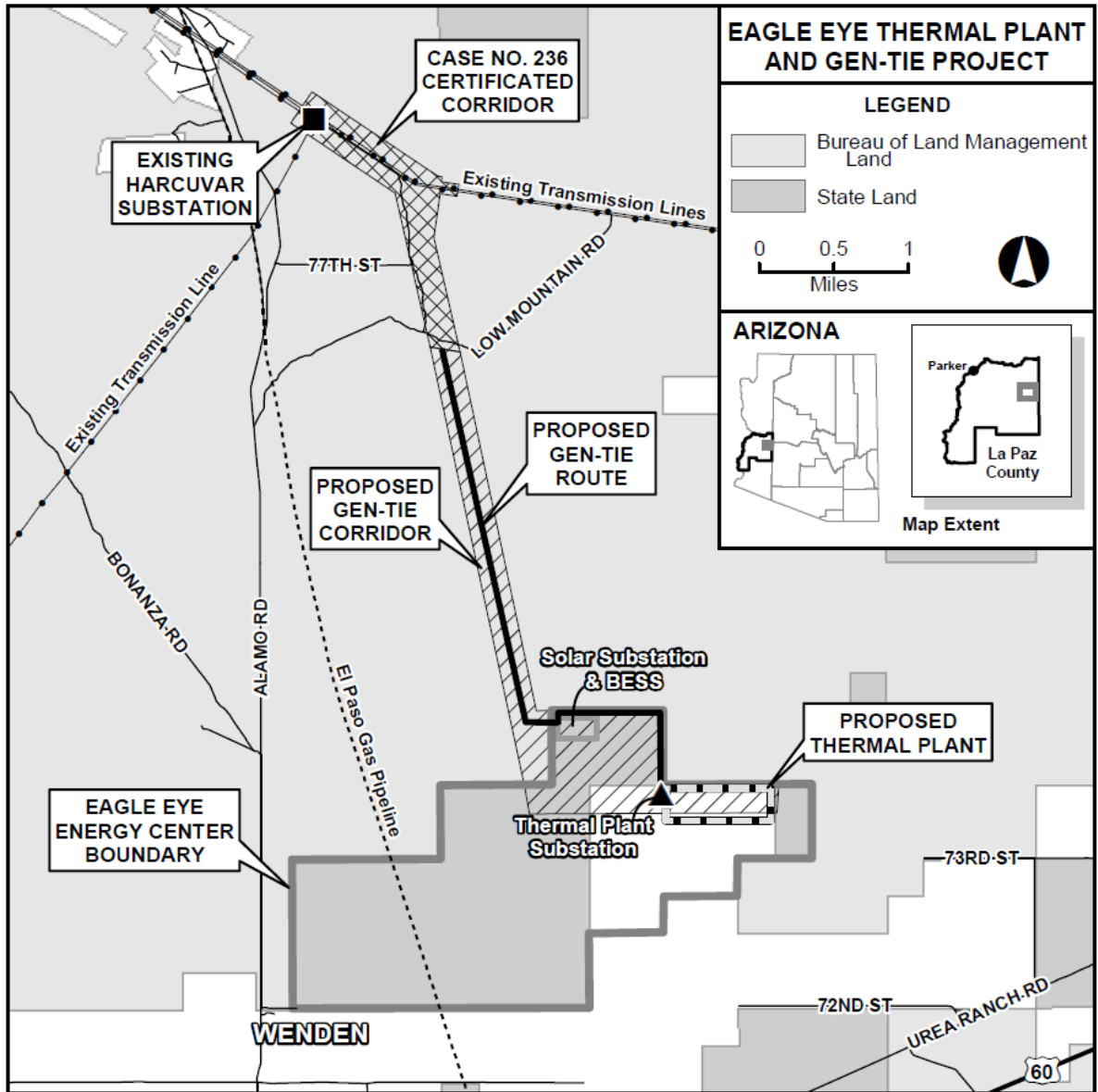
