BrightNight is seeking proposals for a long-term power purchase agreement for its utility-scale, renewable Opportunity Solar and Storage Project (the "Project") located in Anaconda, Montana.


About BrightNight

Financial Strength

Because of BrightNight's experienced team of industry leaders, its differentiated pipeline of renewable power projects, and its in-house optimization tools, we have

garnered financial support for some of the industry's leading investors. BrightNight enjoys a joint venture partnership with Cordelio Power (a Canadian Pension Plan Investment Board company) and support from Global Infrastructure Partners (GIP). These combined investments allow BrightNight, as an independent power producer (IPP), to offer its customers a single point of service from development through operations.

2. PROJECT HIGHLIGHTS

The Project will be situated on one of the nation's largest Superfund sites and will be a showcase for redeveloping a brownfield site with very limited suitability for other productive use into an asset for the local community and the region. The Superfund site has been remediated and is ideally suited for this Project.

BrightNight has received enthusiastic support from Anaconda-Deer Lodge County, local leaders, and community members. Both the Planning Board and full County Commission voted unanimously in favor of the Major Development (land use) Permit, which was obtained in July 2022. The Project also received support from the regional EPA leaders.

The Project is being developed to include 200-MWac Solar and a 200 MWac/800 MWh Battery Energy Storage System (BESS) and can be ready to begin commercial as early 2025. Large December Α Generator Interconnection Agreement (LGIA) has been executed with Northwestern



Energy. The Project can directly access Bonneville Power Authority (BPA) and Northwestern Energy substations.

Community Engagement

BrightNight takes a comprehensive approach to community engagement beginning with land acquisition and continuing through project operation. During the early

development phase, the project team worked closely to educate local leaders, landowners, and business owners on the economic and environmental value generated and provided to the Project's communities. The Project provides especially significant local value given its utilization of otherwise undevelopable land. The community is eager to see what was once unusable land repurposed for the production of clean, renewable power. The community benefit of the Project includes:

- Clean energy production equivalent to the electricity used by 46,000 homes annually
- Creation of 250 construction jobs with 3-5 long-term careers in operations and maintenance
- \$110M in tax revenue over the life of the project
- Utilization of land not suitable for food production, housing, or recreation
- Potential to attract commercial and industrial businesses prioritizing clean energy as part of their operations

BrightNight has completed the local permitting process and looks forward to supporting a customer's clean power and environmental, social, and governance goals, including the ability of the Project to amplify the unique social impact of the Project on the community and the environment.

BrightNight reserves the right to modify the quantity or the character of any products offered from the Project under this RFP or the proposed Power Purchase Agreement (PPA) / Tolling Agreement, including, but not limited to, energy, capacity, ancillary services, and/or environmental attributes at any time during the solicitation and evaluation process. BrightNight is committed to following a fair process in selecting the winning proposal. However, BrightNight reserves the right, in its sole discretion, to accept or reject any and all proposals at any time and for any reason without incurring any liability for costs or expenses incurred by any bidder in the course of, or as a result of, such bidder's participation in the RFP process or negotiations with respect to the Project. BrightNight will have no obligations to any bidder with respect to the Project unless and until the execution by all applicable parties of one or more definitive written agreements (the "Definitive Agreements") in form and substance satisfactory to the parties entering into such Definitive Agreements, and then only to the extent stated therein. BrightNight envisions entering into a PPA or Tolling Agreement with one or more Bidders for either a solar and storage, solar-only, or storage-only product. We look forward to working with Bidders to create a transaction structure to suit their unique needs.

6. TERM LENGTH

BrightNight's preferred transaction term is 15 years or longer but we are willing to discuss shorter term lengths that may best meet a Bidder's requirements while still

resulting in the development of a high-quality project that satisfies all stakeholder considerations.
